TERMS & CONDITIONS

1. Information on how to enter and prizes form part of these terms and conditions. By participating, entrants are deemed to have accepted the following terms and conditions. Entries must comply with these conditions to be valid.
2. **Who can enter?** Entry is only open to residents of Australia. The Promoter's directors, management, employees, retailers, tenants of participating centres and their immediate families together with agencies and suppliers associated with this Promotion are ineligible to enter.
3. **Permit number:** This Promotion is authorised under [Insert Permit Number] NSW.
4. **Promotion Period:** This Promotion commences at 9am on Thursday 21 January 2010 and closes at 5.30pm on Tuesday 20 April 2010.
5. **How to enter?** To enter, an entrant must, during the Promotion Period:
 - (a) Spend \$10 or more in one single transaction at any store in Charlestown Square; and
 - (b) Be one of the first 150,000 customers to present their receipt to the staff located at one of the entry points during trading hours to have their receipt validated, in which case the customer will receive one (1) official "Scan & Win!" game card;
 - (c) Customers who spend \$10 or more in one transaction on advertised 'Double Entry' days will receive 2 "Scan and Win!" game cards per valid receipt.
Entry points are located as follows:
 - i) the Customer Service Desk at the Pearson Street entry on level 2; and
 - ii) the Concierge Desk at the top of the travelators on level 1.
 - (d) Scan the barcode on their "Scan & Win!" card at a scanning machine located at an entry point to reveal if they are an instant prize-winner and if so, present their "Scan & Win!" card to the staff at the entry point to collect their instant prize voucher.
 - (e) Whether or not an instant prize has been won, complete their details on the reverse of the "Scan & Win!" card and place it in the barrel or booths located at an entry point during the Promotion Period to enter the draw to win one of the weekly prizes or the major prize.

Unless specified otherwise, it is the sole responsibility of winners to collect their prize. The Promoter will not notify winners of the time remaining.
